## Emergency Shelter Agreement

THIS AGREEMENT, entered into this 1<sup>ST</sup> day of DECEMBER, 2005 by and between the School Board of Okaloosa County, Florida as the governmental agency having jurisdiction over Baker School (hereinafter called the "School") and Okaloosa County Board of County Commissioners, is for the purpose of setting forth the terms and conditions under which the School will be allowed to use the County facilities of the Baker Area Recreation Center in the event of an emergency at the School. This agreement may be terminated by either party based upon a written 30 day notice.

The parties do agree as follows:

1. In the event of an emergency and/or crisis situation at the School, the students, faculty, and staff of the School may be relocated to the facilities of the Baker Area Recreation Center, which will serve as a temporary shelter.
2. The administrators of the School shall be responsible for the supervision of students while they are at the temporary shelter.
3. The School District shall issue a certificate of insurance to the owner of the shelter for the use outlined in this Agreement.
4. Okaloosa County Board of County Commissioners shall not be responsible for transportation of any students, faculty or staff to or from shelter, also it shall be the responsibility of the School for any meals or drinks necessary for said students, faculty or staff.
5. The administrators of the School shall notify immediately of the need for the use of the facility, before any one is relocated.
