AMENDMENT NUMBER 2

This Amendment Number 2 ("Amendment") is made on the date of execution by the County and amends Arlington County Agreement Number 17-191-ITB-2, dated March 13, 2017, ("Main Agreement as Amended") and made between Aerial Machine and Tool dba Capewell Aerial Systems, 4298 JEB Stuart Highway, Meadows of Dan, Virginia, 24120 ("Contractor"), a Maryland corporation authorized to transact business in the Commonwealth of Virginia, and the County Board of Arlington County, Virginia ("County").

Whereas the County and the Contractor desire to amend the Contract Term of the Main Agreement, the Contractor and the County, in consideration of the promises and other good and valuable consideration specified in this Amendment, amend the Main Agreement as follows:
