SECOND AMENDMENT AND RENEWAL TO THE AGREEMENT BETWEEN OKALOOSA COUNTY, FLORIDA AND LA DOLCE VITA, LLC CONTRACT NO. C19-2797-PW

This Second Amendment and Renewal to the Agreement between Okaloosa County, a political subdivision of the state of Florida (the "County"), and La Dolce Vita, LLC (the "Contractor"), day of ____March____, 2023, is made a part of the Agreement between executed this 14th the County and Island Sands Beach Services of NW FL, LLC on April 2, 2019 later assigned to Contractor December 17, 2019, Contract No. C19-2797-PW (the "Original Agreement"), incorporated herein by reference. The County and Contractor hereby agree as follows:

- 1. **OPTION TO RENEW.** The parties hereby wish to exercise their yearly option to renew the Original Agreement for an additional one (1) year term in accordance with Section IV of the Original Agreement, this will be the final renewal of this agreement.
- 2. EFFECTIVE DATE OF RENEWAL TERM. The Effective Date of this Amendment shall commence April 2, 2023 and shall terminate no later than April 1, 2024.
- 3. AMENDMENT. The parties hereby agree to amend Attachment "A" the Scope of Services as referenced and incorporated in to Section II of the Original Agreement as follows:
 - a. Ross Marler Public Park is hereby removed from the service area for the Contractor to provide services. Contractor's rental of beach chairs and umbrellas under this Agreement shall only be at the following public parks: Newman C. Brackin (The Boardwalk), John Beasley, and James Lee (Destin) public parks.
 - b. Contractor shall **ONLY** provide Chair and Umbrella service.
 - c. No set-ups shall occur by Contractor prior to 7:30 am at any location.
 - d. Contractor shall only set up within the site set-up areas of each of the three (3) locations that are shown on the attached site set-up maps attached, as Attachment "1" hereto and incorporated herein.
 - e. Contractor shall adhere to all rules and regulations as set forth and established in any County Ordinance and the Okaloosa County Code of Ordinances.
- 4. **COMPENSATION.** Compensation for this renewal term of the Agreement shall:

The Contractor shall submit to the County payment in the amount of \$170,500.00 annually for the









Attachment "A" Site Map

James Lee Park - Destin




Newman C. Brackin Wayside (Boardwalk) Park
