STATEMENT OF ISSUE: A request has been received from a group named Warrior Base Airsoft, to use county park property in Laurel Hill (Old Laurel Hill Landfill) for an Airsoft field.

BACKGROUND AND ANALYSIS: Warrior Base Airsoft is requesting the use of approximately 20 acres of county park property to utilize to hold Airsoft games, to unite the Airsoft community and intoduce the public to Airsoft. Airsoft is a much safer alternative to Paint Ball, it uses small BB size balls that are shot from a weapon at human targets, they are biodegradable and not as harmful as Paint Balls.

Warrior Base had been using fields provided by the City of Fort Walton. This field was used until the City of Ft Walton closed the property for renovation. They were hopeful to find an alternate location that they could develop to meet their needs. The Old Laurel Hill Landfill site will meet the needs.

They request to enter into a Facility Maintenance Agreement with the County. Warrior Base would build some portable buildings that could be easily removed, provide grounds maintenance, and clear a small area for a parking area. In return for the use of the property, the site when not in by Warrior Base, will be open for anyone to use and Warrior Base would utilize any fees collected from the use of the property for upgrades and continued property management.

Warrior Base has been involved with the Law Enforcement Academy at Northwest Florida State College in assisting with training with recruits for building entry and arrest techniques and plan on continuing to assist them with their training.

The property at the Old Laurel Hill Landfill was retained by the Parks Division in accordance with the Parks Master Plan. It was Land Banked for future use as development occurs. It is isolated at the end of Robbins Road and is surrounded by vacant wooded land tracts. This type of activity will provide a recreational need in the county.

Staff believes this to be a worthwhile program and would benefit the Parks with maintenance costs and groundskeeping staff time.



### Facility Management Lease Between Board of County Commissioners Okaloosa County, Florida To Warrior Base Airsoft

The Board of County Commissioners, Okaloosa County, Florida (Hereinafter referred to as "COUNTY") leases to Warrior Base Airsoft (Hereinafter referred to as "LESSEE") the property formally known as the Laurel Hill Landfill, and retained for Park property. This lease is effective the 16<sup>th</sup> day of July, 2013. For and in consideration of the use of the property Warrior Base Airsoft, the parties hereto agree as follows:

- 1. LESSEE is granted sole authority to manage the property for events organized or approved by LESSEE throughout the year. During times the LESSEE has no events scheduled, LESSEE shall allow the general public to use the premises without charge. COUNTY employees have the right to enter the property when deemed necessary and to inspect the property for compliance.
- 2. All organizations or vendors authorized to schedule events by the LESSEE shall carry adequate commercial liability, workers compensation and other insurance to protect the interest of the COUNTY and the LESSEE. The nature and activity of the event shall determine the amount of insurance required; however, the amount of such liability coverage shall not be less than a combined single limit of one million dollars (\$1,000,000.00). In addition, such organizations and vendors shall sign an indemnification and hold harmless agreement in favor of the COUNTY and the LESSEE.
- 3. **LESSEE** is responsible for maintaining the premises in a clean, safe and sanitary condition. This includes housekeeping and lawn maintenance and trash pickup and removal. All trash and waste material shall be removed promptly.
- 4. **COUNTY** shall pay the water, and electric utilities. **COUNTY** shall perform minor repairs to the county portion of the roadway and onsite parking area.
- 5. LESSEE agrees to utilize revenues derived from the use of the facilities, including fees and event profits, for the general facility maintenance, facility improvements and recreational improvements and recreational functions. Additionally, LESSEE agrees, that within (90) days of the end of the County's fiscal year, to provide the County with an audit performed by an independent certified accountant of all income and expenses.
- 6. The term for this lease shall be two (2) years from the effective date. This Agreement may be terminated by either party, at any time, with or without cause, upon no less than one hundred-twenty (120) days notice, in writing to the other party. On expiration of the two (2) year term, the lease may be renewed with the mutual agreement of **LESEE** and **COUNTY**.

- 7. The annual lease fee is one dollar.
- 8. Under no circumstance is **LESSEE** to be considered an agent or employee of the **COUNTY**.
- 9. LESSEE shall maintain public liability insurance against Bodily Injury, Property Damage and Personal and Advertising Injury exposures. The amount of such liability coverage shall not be less than a combined single limit of three-hundred-thousand dollars (\$1,000,000.00). The insurance contract shall list Okaloosa County as an Additional Insured.
- 10. To the fullest extent permitted by law, **LESSEE** shall indemnify and hold harmless **COUNTY**, its officers and employees from liabilities, damages, losses, and cost including but not limited to reasonable attorney fees, to the extent caused by the negligence, recklessness, or intentional wrongful conduct of the **LESSEE** and other persons employed or utilized by the **LESSEE** in the performance of this Agreement.
- 11. **COUNTY** retains the right to post safety and other informational signage on the property. The presence or absence of such signage shall not relieve **LESSEE**, organizers or vendors from warning the public about hazards associated with particular events.
- 12. LESSEE shall not construct any structure or make modifications to existing facilities during the term of this lease unless approved by the Board of County Commissioners. Any construction will require structures to be temporary and constructed is a neat and presentable manner. All construction must address safety, drainage, and parking. Necessary repairs can be made without approval. All elements used for execution of Airsoft Games must be temporary and easily removable,
- 13. **LESSEE** shall be responsible for providing County with a schedule of all events on the property. Changes without notice or mis-representation of schedule could result in termination of agreement.
- 14. LESSEE agrees that all Airsoft pellets used on the property must be bio-degradable.
