

TASK SERIES 4000: Live Oak Church Road Post Design

Summary of Work:

The Live Oak Church Road Project consists of widening Live Oak Church Road for a distance of approximately 0.33 miles from SR 85 to Shoal River Drive. This project is expected to be bid for construction in June 2023 with estimated construction duration of 8 months. HDR previously prepared the roadway plans for this project. This scope and fee describes the post design assistance for such items as follows:

- Shop Drawing review (Drainage Structures and Mast Arms)
