AMENDMENT NUMBER 2

ASSIGNED CONTRACT NO. 16-236-ITB-LW

This Amendment Number 2 ("Amendment") is made on the date of execution of the Amendment by the County and amends Agreement dated March 16, 2017 ("Main Agreement") and made between Rojani Facilities Mgmt, LLC of 5200 Baltimore Avenue, Suite 102, Hyattsville, Maryland 20781 ("Contractor") and the County Board of Arlington County, Virginia ("County").

Whereas the County and the Contractor desire to amend the Contract Term under the Main Agreement, the Contractor and the County, in consideration of the promises and other good and valuable consideration specified in this Amendment, amend the Main Agreement as follows.

ADD THE FOLLOWING LANGUAGE TO SECTION 6. INVOICING:

Invoices submitted for Purchase Orders issued by APS (Arlington Public Schools) for those locations identified in Group IV of the Scope of Services shall be sent to Arlington Public Schools, Facilities and Operations, Plant Operations Services, 2770 South Taylor Street, Arlington VA. 22206.

ADD THE FOLLOWING LANGUAGE TO SECTION 8. PAYMENT TERMS FOR THE COUNTY

Payments will be made by APS for services, delivered, inspected, and accepted only for those locations identified in Group IV of the Scope of Services upon receipt of invoices submitted on the date delivery of service, subject to applicable payment terms. The number of the APS Purchase Order pursuant to which authority services have been performed shall appear on all invoices. Invoices shall be submitted in duplicate. Unless otherwise specified herein, payment shall not be made prior to delivery and acceptance of the entire Work by APS.

ADD THE FOLLOWING LANGUAGE TO SECTION 11. PURCHASE ORDER REQUIREMENT:

APS purchases are authorized only if an APS Purchase Order is issued in advance of the transaction, indicating that the ordering agency has sufficient funds available to pay for the purchase. Such a Purchase Order is to be provided to the Contractor by the ordering agency. APS will not be liable for payment for any purchases made by its employees without appropriate purchase authorization issued by the APS Purchasing Agent. If the Contractor provides goods or services without a signed APS Purchase Order, it does so at its own risk and expense.

CONTRACTOR CERTIFICATION
REGARDING CRIMINAL CONVICTIONS

This form must be completed by an authorized official for any organization contracting to provide services under a contract with the Arlington Public Schools or any of its schools or departments, or any subcontractor under such contractor.


The completed form from the Contractor is a condition precedent to the award of the Contract.

As the official authorized to enter into this Contract on behalf of my organization, I certify that:

1. No employee of the organization who will have direct contact with students on school property during regular school hours or during school-sponsored activities during the performance of this Contract has been convicted of a felony or of any offense involving the sexual molestation, physical or sexual abuse or rape of a child; and
2. As more particularly set forth in Virginia Code Ann. Section 18.2-370.4, no employee who has been convicted of rape, forcible sodomy or object sexual penetration, all of a child under 13, during the commission of abduction, in the course of entering a dwelling with intent to commit murder, rape, robbery, arson, larceny, assault and battery, or any felony, or of aggravated malicious wounding will enter upon the property of an existing elementary or secondary school in the performance of the Work; and
3. As more particularly set forth in Virginia Code Ann. Section 18.2-370.5, no employee who has been convicted of a sexually violent crime shall enter upon the property of any existing elementary or secondary school during school hours or during school-related or school sponsored activities in the performance of the Work.

I understand that a materially false statement regarding this certification is a Class 1 misdemeanor and that conviction of such misdemeanor shall result in the revocation of this Contract and of any related license that I may hold. I declare under penalty of perjury that the foregoing statements are true and correct.
