AGREEMENT NO. 516-12
AMENDMENT NUMBER 1**

This Amendment Number 1 ("Amendment") is made on the date of execution of the Amendment by the County and amends Agreement Number 516-12 dated August 8, 2011 ("Main Agreement") and made between **Job Discovery, Inc.** ("Contractor") and the County Board of Arlington County, Virginia ("County").

Whereas the County and the Contractor desire to amend the contract term under the Main Agreement, the Contractor and the County, in consideration of the promises and other good and valuable consideration specified in this Amendment, amend the Main Agreement as follows:

A. PARAGRAPH NO. 3, CONTRACT TERM, SHALL BE DELETED IN ITS ENTIRETY AND REPLACED WITH THE FOLLOWING:

3. CONTRACT TERM

Work under this agreement shall continue from July 1, 2012, and be completed no later than June 30, 2013 ("First Subsequent Contract Term"), subject to any modifications as provided for in the Contract Documents. Upon satisfactory performance by the Contractor and with the concurrence of the Contractor, the County may authorize continued operations of the Contractor for not more than eight (8) additional twelve (12) month periods from July 1, 2013 to June 30, 2021 (Each such period shall be referred to as a "Subsequent Contract Term"). The rates and Contract Amount for each Subsequent Contract Term shall be in an amount mutually agreed upon but which will in no event exceed the funds appropriated for the service by the County Board of Arlington County. The total Contract Amount may be increased or decreased during Subsequent Contract Terms if available funds exceed or, in the alternative, are not sufficient to maintain then current service levels.

B. RATES AND CONTRACT AMOUNT FOR THE "FIRST SUBSEQUENT TERM" REMAIN THE SAME AS THE "INITIAL CONTRACT TERM".

All other terms and conditions of the Main Agreement shall remain in full force and effect.
