AMENDMENT NUMBER 1**

This Amendment Number 1 is made on the date of execution by the County and amends Agreement Number 20-044-SFA ("Main Agreement") dated August 14, 2019 between M&E Services, Inc. dba FitrepairsNVA ("Contractor") and the County Board of Arlington County, Virginia ("County").

The County and the Contractor agree to amend the main contract called for under the Main Agreement as follows:

- 4. The Contractor shall continue to provide the services and must be completed no later than **June 30, 2022** ("Subsequent Contract Term"). Upon satisfactory performance by the Contractor may authorize continuation of the Agreement under the same contract prices for not more than two (2) additional 12-month periods from **July 1, 2022 to June 30, 2024** (each a 'Subsequent Contract Term'). The initial Contract Term and any Subsequent Contract Term(s) are together the "Contract Term".

- Amend Exhibit A Equipment List to add two (2) additional locations as follows:

LONG BRIDGE	1 VISIT AT \$2,170.00 X 4 = \$8,680.00 ANNUALLY
LUBBER RUN	1 VISIT AT \$525.00 X 4 = \$2,100.00 ANNUALLY

All other terms and conditions of the Main Agreement remain in effect.


