

RESOLUTION NO. 16-270

A RESOLUTION APPROVING THE LEASE OF TEN UNMARKED VEHICLES FROM ENTERPRISE LEASING COMPANY OF ORLANDO, LLC (ENTERPRISE), FOR THE PERIOD COMMENCING OCTOBER 1, 2016, AND ENDING SEPTEMBER 30, 2017, FOR A TOTAL ANNUAL AMOUNT NOT TO EXCEED \$76,000; AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE THE PREFERRED RATE AGREEMENT WITH ENTERPRISE, GENERALLY INCORPORATING THE TERMS AND CONDITIONS OF THE CITY OF PALM BAY POLICE DEPARTMENT PREFERRED RATE AGREEMENT; AUTHORIZING AMENDMENT OF THE FY 2016/17 REVENUE AND EXPENSE BUDGET IN THE AMOUNT OF \$52,000 FOR THE LEASE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Section 30-54(b), City Code, authorizes the City to make purchases from vendors who have entered into contracts with other governmental entities without competitive selection; and

WHEREAS, the Police Chief desires to lease ten unmarked vehicles for the undercover unit for the period commencing October 1, 2016, and ending September 30, 2017, using law enforcement trust funds, and has provided written certification that the request complies with the provisions of § 932.7055, Florida Statutes; and

WHEREAS, the vehicles are available from Enterprise Leasing Company of Orlando, LLC, pursuant to a Preferred Rate Agreement with the City of Palm Bay Police Department, at an annual cost not to exceed \$76,000; and

WHEREAS, the Police Chief recommends the use of \$52,000 of unspent funds from FY 2015/16 for the lease, and that the Budget Officer be authorized to amend the revenue and expense budget for FY 2016/17 accordingly.

WHEREAS, the Chief Financial Officer has submitted a Sufficiency of Funds Certificate.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DAYTONA BEACH, FLORIDA:


SECTION 1. The lease of ten unmarked vehicles from Enterprise Leasing Company of Orlando, LLC, for a period commencing October 1, 2016, and ending September 30, 2017, for a total annual amount not to exceed \$76,000, is hereby approved.

SECTION 2. The Mayor and City Clerk are hereby authorized to execute the Preferred Rate Agreement with Enterprise Leasing Company of Orlando, LLC, generally incorporating the terms and conditions of the City of Palm Bay Police Department Preferred Rate Agreement. A copy of the Agreement in substantially final form is attached hereto and made a part hereof by reference.


SECTION 3. In accordance with the requirement of § 932.7055(5)(b), Florida Statutes, the City Commission acknowledges receipt of the request and written certification of the Police Chief that the request complies with the provisions of § 932.7055, Florida Statutes, and hereby authorizes the expenditure of law enforcement trust funds for this purpose.

SECTION 4. The Budget Officer is hereby authorized and directed to amend the FY 2016/17 Revenue and Expense Budget in the increased amount of \$52,000 based on unexpended revenues received prior to FY 2016/17, in order to appropriate funds for the expenditure herein.

SECTION 5. This Resolution shall take effect immediately upon its adoption.
